At Alloway Church, on the Sixth Day of October, Two Thousand and Nine Years, the Presbytery of Ayr met and was constituted with prayer.

- **859. WELCOME.** The Moderator welcomed Mrs Nancy Jackson, Auxiliary Minister, Mr Stuart Kilpatrick, Additional Elder and Dr David Geddes, Additional Elder.
- **860. MINUTES.** The Minutes of the Meeting of 1<sup>st</sup> September 2009, being in the hands of Members, were taken as read and approved.
- **861. RETIRING MODERATOR.** The Moderator's term of office being completed, the Clerk, on behalf of the Court, thanked Mr Paterson for his thoughtful meditations and his firm grasp of Presbytery business.
