As you will know, for a number of years, the Department has supplied style contracts of employment for the types of posts most generally found within Congregations - Organist, Church Officer etc.

We have recently reviewed these styles in the light of employment law changes and in particular the abolition of the Default Retirement Age. The styles also take into account the new arrangements in terms of the Protection of Vulnerable Groups Act 2007 in regard to the requirements for Scheme membership for those undertaking regulated work with children, young people and protected adults.

I hope that the additional information proves helpful. As before, there are separate styles for Congregational Boards and Kirk Sessions to take account of different constitutional arrangements.
