All relevant matters being in order and the Clerk having laid on the Table the prescribed Edict duly executed, no one having appeared to object to the life or doctrine of the said Rev Jamie Milliken, the Presbytery resolved to proceed to the Induction of the Rev Jamie Milliken to the Pastoral Charge of Troon: Portland.

Public Worship was conducted by the Rev David Albon, Minister of Mauchline linked with Sorn, who preached a sermon appropriate to the occasion. The Narrative and Preamble having been delivered and the prescribed Questions asked and answered satisfactorily, the Rev Jamie Milliken signed the Formula.

The Moderator, with prayer, did induct the Rev Jamie Milliken and admit him to the Pastoral Charge of Troon: Portland. With other Presbyters, the Moderator gave him the Right Hand of Fellowship. **2.      AYR: ST COLUMBA**

The Presbytery approve the application by Ayr: St Columba to undertake essential masonry work and re-leading of the Church roof, including restoration works to the sandstone cross on the east gable and re-alignment of copings, in a total sum of £40,000 (inc VAT). Funds are available . No disruption of Church services is anticipated.

- a.      The Presbytery receive the Report.
- b.      The Presbytery accept the percentages for Mission, Relief and Contingencies within the 3% Discretionary amount for 2012 as Mission 30%, Relief 50% and Contingencies 20%; for 2013 as Mission 40%,Relief 40%, and Contingencies 20%; for 2014 and thereafter Mission 50%, Relief 30% and Contingencies 20%.
- c.      The Presbytery agree to establish a sub committee to consider and recommend approval / declinature of applications from Congregations for Reduction in full Ministry & Mission contributions. This permanent sub committee to comprise of three members from Administration Committee, one of whom must be the Vice Convener Finance, two members from the Mission Committee and one member from the Education Committee. Their recommendations to be reported for ratification by Presbytery via the Administration Committee.
- d.      The Presbytery agree that henceforth applications for Reduction in full Ministry & Mission contributions from Congregations should be in writing, in the first instance, to the Vice Convener Finance and supported by additional information as outlined in the Report. The Vice Convener Finance will within 7 days acknowledge the communication and thereafter call a meeting of the committee to consider the application.
- e.      The Presbytery instruct the Administration Committee to produce for Presbytery each September a list of those Congregations who have been granted Reduction detailing the reason for reduction and the amount involved.

f. The Presbytery agree that the Trustees of each Congregation whose Ministry & Mission contributions are more than £1000 below the scale figure should at an early date be visited by 3 members of the Administration Committee with a view to encouraging a review of giving arrangements and consideration of entering a Giving Agreement with Presbytery. The Administration Committee to report the outcome of such meetings to Presbytery by no later than May 2012.

g. The Presbytery thank and discharge the ad hoc committee.
