## 25 years: Rev Bill Hannah, Minister emeritus Muirkirk Parish Church.

Mr Bill Mackie, ruling Elder, paid fitting tribute to the Rev Bill Hannah. From a career in journalism, Bill had accepted the call to the ministry. Throughout his time at Muirkirk, Bill had been a very diligent and passionate Minister. In addition, he was still a wonderful servant to the Presbytery of Ayr, a past Moderator, current Editor of Newslines and continuing to travel from his home in Kirkintilloch to attend meetings. Bill was truly a Minister who was dedicated to Church, ably supported by his wife Morag.

The Moderator installed the Rev Alastair Symington with prayer, handed him the Ordinal and a Bible donated by Words of Wisdom, and put on his shoulders the Moderator Scarf and declared him duly installed as Moderator of the Presbytery of Ayr for the year ending 1<sup>st</sup> October next, and then gave him the Right Hand of Fellowship.

The Rev Alastair Symington took his place and acknowledged Court. The Meeting was adjourned.

# **246. ADMINISTRATION COMMITTEE**, given in by Mr C Cameron, Convener, who moved the following Deliverance, which was adopted:-.

#### 1. STUDY LEAVE.

The Presbytery approve the application for study leave as submitted by the Rev Neil McNaught, for four weeks to St George's in Jerusalem, for an ethnological study course of the Holy Land at the lifetime of Jesus.

The Presbytery instruct the Clerk to send an Extract Minute to the Senior Administrator of the Ministries Council.

### 2. AYR: NEWTON WALLACETOWN CHURCH.

The Presbytery approve the application by Newton Wallacetown Church for provision of access scaffolding at a cost of £576.00 including VAT. This is to enable repairs to the rose window to be carried out. The repairs to the Rose window were approved at the December meeting of 2011 as part of a larger project. The proposal includes an application for the release of funds from their account in the Consolidated Fabric Fund. The appropriate form has been completed.

## 3. IMPORTANT INFORMATION REGARDING THE COMMITTEE ON CHURCH ART AND ARCHITECTURE.

The Presbytery note that all Congregations are reminded that alterations to Church buildings, including decoration of the sanctuary, must have the approval of the Committee on Church Art and Architecture.

The Church of Scotland enjoys the privilege of interior alterations to its buildings being exempt from the normal planning processes due to the "ecclesiastical exemption" provision. This exemption, however, depends on the Committee on Church Art and Architecture being in a position to provide expert guidance and advice to Congregations contemplating or planning alterations, as well as to the General Trustees.

PRESBYTERY OF AYR

In recent months, the Committee has become aware of several cases where significant alterations of church buildings have been undertaken by congregations without the General Trustees or the Committee being consulted. Since some of these alterations have been made to buildings which are designated as being of historic importance, this raises serious issues for the relationship of the Church of Scotland with Historic Scotland. If Congregations continue to alter their buildings without proper consultation of the Committee and the General Trustees, continuation of our "ecclesiastical exemption" is likely to be put at risk. This could result in a presbytery and all the charges within its bounds being required for a period of years to submit all alterations through the normal planning processes in addition to those of the Church of Scotland.

It is also important to remember that the Committee and the General Trustees are there to offer objective guidance and advice, including free access to professional expertise, and that their input has proved very beneficial to Congregations in planning their alterations.
