The Presbytery remind all Congregations within the bounds that they must deposit an originally signed copy of their Accounts (including the relevant financial statements, with notes, and the annual Trustees report) for 2013 with the General Treasurer of the Church of Scotland no later than 31<sup>st</sup> March 2014.

#### 2. EXAMINATION OF LOG BOOKS
